Candidates for First and Second District Supervisor to Debate on December 14th

Everyone is invited to attend a Candidate Forum to become acquainted with the contenders running to represent both the First and Second Districts on the Mendoicno County Board of Supervisors. The Forum will be held on Thursday, December 14th at 6:00p.m. at the Ukiah Civic Center located at 300 Seminary Avenue, Ukiah, CA.

Mendocino County encompasses five districts, and the boundaries of the First District include Potter Valley, Redwood Valley, Calpella, and Talmage. The Second District contains the City of Ukiah which is the county seat and the largest city in Mendoicno County. Since First District Supervisor Glenn McGourty announced that he will not be seeking a second term, five candidates for the March 5, 2024 primary election have filed initial paperwork to launch their campaigns. Madeline Cline, Adam Gaska, and Trevor Mockel reside in Redwood Valley, and Carrie Shattuck and David Goodman live just outside the City of Ukiah.

Until recently, it appeared that Second District Supervisor Maureen "Mo" Mulheren would be an unopposed incumbent candidate. But on October 17th, Jacob Brown announced that



he was officially a candidate running for the position of Second District Supervisor. Mullheren, a lifelong resident of Ukiah and business owner, has served three years of her first term as Second District Supervisor. Prior to joining the Mendocino County Board of Supervisors, she was on the Ukiah City Council for six years as well as a term as mayor. Brown now lives in the Ukiah neighborhood where he grew up. Since serving in



the Marines, he has been working in manufacturing. Though new to local area politics, Brown is set to challenge Supervisor Mulheren.

The citizens of Districts One and Two are encouraged to identify the issues of concern in

their districts and to put their questions before the candidates. Each candidate will have the opportunity for a short opening and a closing statement. Questions from the audience will be submitted to the moderator on index cards, and each candidate will have equal time to answer the questions and to respond to each other. The moderator will ask as many questions as possible, but will use her discretion to choose questions of most interest to the voting public within the time framework. MWPC member, Christine Poremski Rodrigues, will serve as moderator. Campaign literature will be available on the tables in the foyer.

This Candidates Forum is co-sponsored by the Mendocino Women's Political Coalition (MWPC) and the Ukiah branch of AAUW. MWPC has jointly hosted candidate forums on a regular basis for over 25 years with the goal of educating voters and encouraging voter involvement. MWPC experience has shown that their candidate forums generate increased voter interest and turnout.

At the 2023 Annual Meeting, it was decided that the MWPC members would attend the Candidate Forums. After each Forum, the MWPC members would gather and recommend candidates to represent the district, 60% vote needed.

This recommendation would go to all the current MWPC members in good standing (paid members) to vote for endorsement; 60% vote would be needed to endorse.

MWPC financial contributions to candidate campaigns are available to women who receive the vote for endorsement with MWPC financial support, 60% vote needed.

Report from Ukiah

The City of Ukiah is undergoing several large scale infrastructure improvement projects. Construction is temporarily inconvenient for drivers and pedestrians but should be well worth the wait. Projects include:

• Phase 4 of the purple pipe (recycled water) project is underway and will bring recycled water to the northwest side of Ukiah. Will irrigate Ukiah High School's lawn, the municipal golf course, Todd Grove Park, and more

• Phase 2 of Downtown Streetscape Project continues renovation of State Street with replacement of water and sewer pipes, underground utilities, widened sidewalks, landscaping, new street lights and traffic signals

• Reconstruction and utility improvements on Gobbi, Main and Perkins Streets

City and County staff have agreed on a proposed tax sharing agreement. The BOS will discuss it in January, most likely. If the agreement is approved by both elected bodies, the City will begin annexations of areas to the north and south of the present city limits.

The City Council voted unanimously to require the current owner of the Palace Hotel to submit a plan to stabilize the building or alternatively, demolish it. This is a sad but necessary decision after the City's Chief Building Official determined the hotel has significantly deteriorated and constitutes a threat to the safety of residents and nearby buildings.

The City obtained a \$921,000 grant from the California Office of Emergency Services to build local resiliency efforts and from that funding, a Chief Relience Officer will be hired to support the City's efforts to prepare for and mitigate disasters like wildfires and floods in addition ot executing action items contained in the City's Climate Emergency Resolution.

We will be swearing in a new mayor—Josephina Dueñas— at our December 6th meeting.

Linda Jupiter

With a heavy heart I am letting you know that our dear friend Linda Jupiter died today, peacefully, surrounded by her dearest people, at the time and in the manner that she felt was right given her serious and complex illnesses.

Linda Jupiter was born in New York City on March 26, 1944, and left us on November 14, 2023, in Fort Bragg, CA, following a short but complicated series of illnesses.

Linda moved to LA to start her adult life in 1967, traveled through Europe and points east and upon return settled in San Francisco in the early 1970s, becoming part of that city's transformation into a welcoming and safe place for gay people.

After moving to Ft. Bragg in 2010, she brought her energy and activism to the north coast, becoming a force in our local community for progressive politics. In the 25 years she lived here, she was a mover and shaker for any number of organization and causes: a mediator for VORP (Victim Offender Reconciliation Program), a constant participant with the Grassroots Institute, a membert of the Latino Coalition, the MCJC (Mendocino County Jewish Community) Justice Group, stood with Women in Black for Peace, a long-time organizer of our Martin Luther King Day celebration, assisted in Anne Turner's Citizenship and ESL classes, co-facilitated the MCJC Elders' group on Zoom, and, with others, fought for years to keep our hospital's obstetrics department open.

She created Jupiter Productions, a book production company, which, in turn, allowed her to hire many local people as editors, indexers & art directors, adding much needed jobs to the community.

Linda loved living in her light, comfortable house in the middle of Ft. Bragg, close to everything she needed. Her years here, she maintained, were the best of her life.

She is survived by her daughters Annie Jupiter-Jones and Ingrid Scantlebury, son-in-law Alejandro Alcantar, granddaughters Justice Kaya Alcantar, Havana Mia Alcantar, and Rio Bella Alcantar; grandsons Jarid Dyon Scantlebury and Aren Malik Scantelbury, as well as her sister Carla Jupiter, brother-in-law Steve Antler & co-parent Diane Jones. She will be sorely missed by her family, and her many friends, colleagues, and fellow activists.

Best Country to Be A Woman

Denmark is the top country in the world to be a woman, according to the 2023 Women, Peace and Security (WPS) Index, which was launched today at the Norwegian Mission to the United Nations in New York.

The country scores more than three times higher than Afghanistan, which ranked the lowest on the index.

The WPS Index, published by Georgetown University's Institute for Women, Peace and Security (GIWPS) and the Peace Research Institute Oslo (PRIO), draws on recognized data sources to measure women's inclusion, justice and security in 177 countries.

Denmark, Switzerland, Sweden, Finland and Luxembourg led the rankings on the top countries for women. Afghanistan, Yemen and the Central African Republic ranked among the lowest.

"Countries where women are doing well are more prosperous, peaceful, democratic and better prepared to respond to the impacts of climate change," said Elena Ortiz (SFS'21), a Georgetown alumna who is the lead author on the report. "When women are doing well, everyone in society is doing well, and our index shows that."

The 2023 edition of the global Women Peace and Security Index (WPS Index) scores and ranks 177 countries in terms of women's inclusion, justice, and security.

International

The International Day for the Elimination of Violence Against Women is observed worldwide on November 25 each year, as designated by the United Nations General Assembly. The day aims to create awareness that women are victims of various forms of violence, including domestic violence and rape.

From UN Women:

"Violence against women and girls remains one of the most prevalent and pervasive human rights violations in the world. Globally, an estimated 736 million women — almost one in three — have been subjected to physical and/or sexual intimate partner violence, non-partner sexual violence, or both, at least once in their life.

This scourge has intensified in different settings, including the workplace and online spaces, and has been exacerbated by post-pandemic effects, conflicts, and climate change.

The solution lies in robust responses, including investment in prevention. However, alarmingly, data on how much nations are committing to counteract violence against women and girls remains glaringly sparse.

For instance, just 5% of government aid is focused on tackling violence against women and girls, and less than 0.2% is directed to its prevention.

We need more investment in women's organizations, better legislation, prosecution of perpetrators, more services for survivors, and training for law enforcement officials.

The International Day for the Elimination of Violence Against Women will mark the launch of the UNiTE campaign (Nov 25- Dec 10) — an initiative of 16 days of activism concluding on the day that commemorates the International Human Rights Day (10 December)."
