BOARD OF SUPERVISORS

1. What skills or experience will you bring to understand and improve the County's finances?

I started my own business at 20 which is still in operation today. I was on the board of Ukiah Natural Foods for 11 years. Currently I am on Redwood Valley County Water District and helped turn it away from bankruptcy by securing water to sell to our domestic and ag customers. I can read financial statements. I know how to be a responsible fiduciary agent.

2. What actions would you take to restore the public's faith in the ability of the Board of Supervisors to govern?

I would work to make the County more transparent and accessible. I would push for all supervisors to put out monthly reports about the committees they are on and the work they're doing for the community as supervisor. I would reassert the supervisor's role in managing the County along with the executive office by switching to a CAO model where the board would lead by setting policy and managing department heads independent of the executive office by setting goals and expectations, then evaluating progress on mutually agreed upon goals on a consistent basis.

3. What steps would you take to improve morale and reduce turnover among County staff?

I would work with the union to develop a system that supports employees through training and a functioning HR department that rewards and promotes employees based on merit and not on cronyism. I would work to get county finances in order so we can pay competitive wages.

4. What do you see as the main drivers of homelessness in the County? What approaches do you believe should be implemented or enhanced to promote stable housing for County residents?

Homelessness is driven by economics, drug abuse exacerbated by mental illness, and a support system that isn't actively engaging the homeless population enough. We need more affordable housing, better paying jobs and we need to be more proactive in encouraging those on the streets to seek and accept services. We don't have a comprehensive enough system to close the gaps, people fall through the cracks and find themselves stuck struggling with their substance abuse and mental illness which reinforces their homelessness.

5. What steps can the County take to protect our environment, manage our resources, and mitigate the negative effects of climate change, including droughts and wildfires?

The primary way the County affects these issues is through land use policy. We need to create and implement policies that prioritize these issues. The County needs to require development and business to conserve resources and encourage more sustainable practices.
